PURPOSE

Roxbury Sewer Separation Phase 3 is a continuation of the work recently completed on Dudley Street and involves the separation of the combined sewer system into a new sewer system and new drain system. This project will reduce pollution levels in Boston Harbor by substantially decreasing the number and volume of combined sewer overflows. This project will also include some water main replacement work as well. The purpose of this notice is to provide information regarding the ongoing improvements in your neighborhood and any necessary impacts or disruptions that might result from this work.

ANTICIPATED IMPACTS

The anticipated impacts include water service interruptions, noise, traffic and parking modifications, rodent activity, dust, and general construction impacts. The contractor will be required to minimize impacts to the extent feasible. Outbound traffic on Blue Hill Avenue and various sections of Moreland Street will be detoured to facilitate the work.

SURFACE RESTORATION

Temporary restoration of roadways, sidewalks and other areas disturbed by construction will be completed under this contract. Permanent paving restoration will occur under a separate contract.





MGCC BizMPower Grant Program

The Mass Growth Capital Corporation (MGCC) has once again launched its <u>Biz-M-Power Crowdfunding Matching Grant Program</u>. The deadline for the newest round of the MGCC BizMPower program is June 30th, 2024. The program overview is below.

Grant Guidelines

- Grants will range from \$2,500 to a maximum of \$20,000.
- If businesses raise a minimum of \$2,500, MGCC will award a matching grant. Examples below:
 - Total project costs \$5K. The business owner raises \$2,500 and receives a grant of \$2,500.
 - Total project costs \$12k. The business owner raises \$6k and receives a grant of \$6k.


